Saskatoon Fringe Theatre Festival
**General Rules and Regulations
for Food Vendors**

In consideration of being granted a license to use the specified space of the Saskatoon Fringe Theatre Festival the undersigned (Licensee) agrees to all terms, conditions, and covenants herein contained.

1. All Licensees, their agents, employees, affiliates, invitees, contractors, subcontractors, or workmen are subject to these General Rules and Regulations.
2. Liability:
 - a. The Licensee agrees that it will indemnify and hold harmless 25th Street Theatre Centre of, from, and against all claims, demands, actions, damages, loss, costs, liabilities, expenses, and judgments incurred by, recovered from, or imposed on 25th Street Theatre Centre in account of injury or damage to persons or property caused either proximately or remotely, wholly or in part, by the negligence or willful misconduct of the licensee, or of its agents, servants, employees, volunteers, patrons, or guests.
 - b. The licensee agrees that all property which the licensee has on the premises referred to in this contract is the responsibility of the licensee and is in its care, custody, and/or control.
3. The Licensee expressly covenants and agrees to obey all Municipal, Provincial, and Federal Statutes, Bylaws, and Regulations and to obtain such necessary permits, licenses, or other authorizations as may be required by Federal, Provincial, and Municipal regulations.
4. No portion of the property or premises covered by this agreement may be sublicensed or assigned by the licensee unless specifically agreed to in writing by 25th Street Theatre Centre.
5. The Licensee agrees to **observe all parking regulations** which may be in effect, the direction of parking attendants and security personnel, and other such regulations that may be in place on, and surrounding the Fringe Festival site.
6. The Licensee shall be responsible for all damages to or loss of property which results from the granting of this license.
7. 25th Street Theatre Centre reserves the right to inspect the licensed premises at any time.
8. 25th Street Theatre Centre reserves the right to cancel this agreement at any time if, in its opinion, the terms and conditions are not being observed.
9. 25th Street Theatre Centre shall not be liable for any damages incurred by the licensee including those resulting from weather or interrupted hours of operation.
10. 25th Street Theatre Centre reserves the right to relocate or alter the space assigned to the licensee.
11. The Licensee agrees to carry commercial general liability insurance subject to a minimum limit of \$1,000,000 bodily injury and property damage inclusive limit. This insurance shall include all operations and activities associated with the event referred to in this contract.
12. Licensee is required to **provide and place appropriate fire extinguishers**. Contact City of Saskatoon Fire Marshall for inquiries (306) 975-2520.
13. Licensee agrees to maintain clean premises and observe sanitary food handling practices. All food vendors are subject to **permit and inspection by the Community Health Unit**. Contact (306) 655-4605 for inquiries.
14. No soliciting for any purpose will be permitted except from within the space licensed for that purpose.
15. **Refuse containers** are the responsibility of the licensee. All refuse must be placed in the designated bins in that area.
16. **Waste Water** must be held in reservoirs and is the responsibility of the licensee to dispose of in an appropriate manner.
17. Power and electrical requirements in excess of 30 amps will be charged an additional fee.
18. Cancellation of agreement on or after July 1 by the licensee or failure to appear on the licensed dates shall result in full forfeit of all fees.
19. **No pegs or stakes** may be driven into any area regardless of surface type anywhere within the Fringe Festival site.
20. The licensee **agrees to remove all materials, supplies, equipment, and displays by the indicated move out time and date**. Failure to comply will result in 25th Street Theatre Centre removing and disposing of any items at the expense of the licensee.
21. Undue noise or unseemly methods of demonstrations employed while operating will not be tolerated. The decision of what constitutes undue noise or unseemly methods shall rest with 25th Street Theatre Centre whose decision will be final.
22. The licensee agrees to abide by all regulations and rules adopted by 25th Street Theatre Centre in the best interest of the festival and agrees that 25th Street Theatre Centre management shall have the final decision in adopting any rule or regulation deemed necessary prior to, during, and after the festival.
23. 25th Street Theatre Centre is committed to maintaining the accuracy, confidentiality, and security of your personal information. It is our policy not to give or sell any information that personally identifies you without your consent.
